Please find below the legally compliant, complete Terms and Conditions structured for the multi-phase pre-launch promotional campaign of Kamino Golf Ltd. These terms protect your corporate cash flow, establish legal boundaries regarding prizes, and ensure compliance with UK consumer protection and advertising legislation.

1. THE PROMOTER

The promoter is Kamino Golf Ltd (hereafter referred to as "the Promoter" or "Kamino Golf"). Registered company number will be appended immediately upon corporate activation.

2. THE PROMOTION STRUCTURE & EXECUTION WINDOWS

This promotional framework consists of three (3) separate random prize draws conducted across the pre-launch validation and marketing sequence. The specific schedules, entry cut-off times, and draw execution sequences are defined below:

- Draw 1 (Autumn Horizon Drop):** Online entries open immediately upon the Phase 1 website launch. Entries strictly close at 23:59 GMT on August 31st. The live random draw will take place on September 1st.
- Draw 2 (Christmas Classic Drop):** Online entries close at 23:59 GMT on December 23rd. The live random draw will take place on December 24th.

The 1st-place prize includes a full custom-fitting session to determine the winner's correct shaft weights, flexes, and lie angles. Kamino Golf Ltd will facilitate, coordinate, and book this session at a certified regional track or a local club convenient to the winner. To secure the company against unpredictable venue fees, **the corporate contribution toward the third-party fitting facility fee is strictly capped at a maximum value of £100.00**. Any premium facility charges exceeding this ceiling are the sole responsibility of the winner. The prize carries zero cash alternative and is entirely non-transferable.

6. ELIGIBILITY & VERIFICATION CONSTRAINTS

The promotion is open exclusively to legal residents of the United Kingdom aged 18 or over at the date of entry submission. Directors, employees, or immediate family members of Kamino Golf Ltd or its associated agencies are strictly excluded from winning. The Promoter reserves the right to request proof of identity and residence prior to fulfilling high-value hardware items.

7. ENTRY CRITERIA & DISQUALIFICATION RULES

Entry is achieved exclusively by joining the official digital pre-launch waitlist via email submission. No transaction or purchase is required. Winners will be generated at random using a verified digital compliance algorithm within 48 hours of each closing deadline. Notifications will be sent exclusively to the email address registered on the waitlist.
